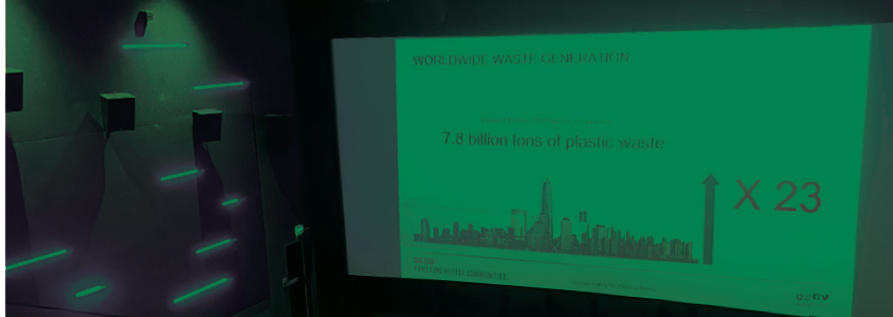

Thank you for your unwavering support and commitment to our shared environmental goals. Together, we can build a brighter, greener tomorrow for generations to come.

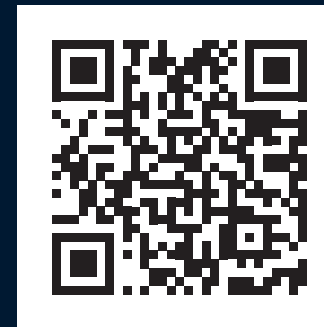

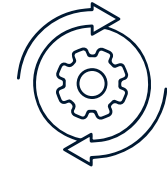

We follow the UAE's circular economy principles, ensuring that waste is repurposed/treated into valuable end products like cement interlocks, re-refined water and oil, and Refuse-Derived Fuel (RDF) for industries.

Complying with Government Mandates and Supporting UAE initiatives:

In line with the UAE Ministry's directives, we help businesses adhere to mandated sustainability initiatives, including waste diversion from landfills, compliance with landfill fees, and supporting several initiatives including the UAE's Net Zero Strategy by 2050. Our solutions are designed to support businesses in reducing their environmental challenges.

Carbon Reduction Focus:

Our solutions contribute to the UAE's emission reduction goals by diverting waste that can be treated away from landfill and converting waste into alternative energy sources. For every 1 tonne of waste we divert away from landfill, we help our customers avoid approximately 2.6 tonnes of CO₂ equivalent in terms of emissions.

Investment in Cutting-Edge Facilities to reduce Environmental Impact:

We continually invest in state-of-the-art facilities and expertise, ensuring that your waste is processed efficiently to meet regulatory targets and industry needs. By diverting waste from landfills, repurposing it into usable products, we help minimise the environmental and economic impact of your operations.

DULSCO RECYCLING BUS

A first-of-its-kind recycling bus in the region, is originally an ex-commercial vehicle of DulSCO that has been recycled and equipped with a number of internal bins as receptacles for different types of recyclable waste like mixed recyclables (including plastic, glass, cardboard, cans and paper), batteries, light bulbs and electronic waste in the recycling bus. The recycling bus is equipped with labeled windows for each type of recyclable waste where people can discard items into.

Aluminium Recycling Coalition launched at EGA in presence of His Excellency Abdullah Bin Touq Al Marri, UAE Minister of Economy, and Her Excellency Mariam bint Mohammed Saeed Hareb Almheiri, UAE Minister of Climate Change and Environment.

Dulscos Environment signed the Climate-Responsible Companies Pledge in line with the UAE Net Zero by 2050 Strategic Initiative.



The Pledge, signed in collaboration with the Government of the UAE and the UAE Ministry of Climate Change and Environment. Dignitaries of the event included H.H. Sheikh Rashid bin Humaid Al Nuaimi, Chairman of the Ajman Municipality and Planning Department, H.E Mariam bint Mohammed Almhiri, Minister of Climate Change and the Environment and H.E. Abdulrahman Al Nuaimi, Director General of the Ajman Municipality and Planning Department.

One of the key milestones in Dulscos Environment's legacy is serving as the Official Waste Management Partner for Expo 2020 Dubai, the first World Expo in the Middle East. Delivering the most sustainable World Expo ever, Dulscos helped achieve a 90.9% waste diversion rate, successfully diverting over 1.1 million tonnes of waste generated from both construction and event operations away from landfills. Through enhanced messaging, communication, and engagement, recycling practices significantly improved among Expo's millions of visitors.



Dulscos Environment showcased its commitment to combating climate change at COP28 in Expo City Dubai by implementing innovative strategies for efficient waste management operations during the event.

The group also sponsored the Waste-to-Resource pavilion in the blue zone ISWA, advocating for the Waste and Resource Management sector's role in reducing greenhouse gas emissions. Additionally, Dulscos Environment endorsed the Waste to Zero: Global Initiative for Waste Decarbonisation, committing to reducing customers' carbon emissions.
